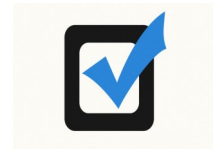

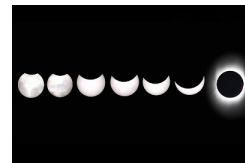

A special welcome for all ninth graders is planned on the first day of school—Thursday, August 17th. Ninth graders need to report to school at 8:10 a.m.. ## From the Nurse...

Welcome back, I hope you had a great summer! We want to keep your student(s) happy, healthy, and safe while at school, so please read the following information carefully.

### ~ Sick Child Policy ~

Please remember if your student is running a fever of  $>100.0$  or has vomiting/diarrhea, please keep them home from school until fever or vomiting free for 24 hours, without the aid of medication (Motrin, Tylenol, Advil, acetaminophen, ibuprofen).

### ~ Physical and Immunization Requirements ~

Nebraska law requires that all school children have a **physical examination** upon entry into school, at seventh grade, and when transferring from an out-of-state school. Students must provide proof of a **visual evaluation** to include testing for amblyopia, strabismus, internal and external eye health and visual acuity upon entry into school and when transferring from an out-of-state school. The law also requires your child be immunized and provide **proof of immunization** before attending classes. Please visit the Nebraska Department of Health and Human Services (link below) which outlines specific vaccine requirements.

### ~ Medication for the 2017-2018 School Year ~

If your student requires any medication (over-the-counter and/or prescription) while at school, each medication must have a Medication Authorization form (link below) signed by the parent and a physician, before we can administer. All medications must be unexpired and provided in the original packaging and/or pharmacy container. For prescription medication, please only provide a **maximum of 30 day supply** at a time.

***All medication must be dropped off in the office by a parent or guardian.  
Please do not send any medications with your student.***

### ~ Students with Asthma, Severe Allergies, Diabetes, and/or Seizures ~

If your child has asthma, severe allergies, diabetes, and/or seizures, please submit an emergency action plan signed by your physician. Plans must be updated annually. Blank forms can be obtained at the school office, or your physician's office can use whichever form they prefer.

## ATTENDANCE AND TARDY POLICY REMINDERS

We understand that sometimes situations arise that cause students to be tardy to school, thus there are no consequences for the first two times students are late. Therefore there is *no such thing as an excused tardy* without documentation from a professional appointment.

- Students are considered tardy when they arrive to school after the 8:10am bell.
- ***Students are considered absent, if they arrive after 8:25am.***

- Please call ahead to the attendance secretary for your student's scheduled appointments. If ample time is given, we can have the student awaiting you in the main office.

- ESHS is a closed campus and students are not permitted to leave for lunch. The practice of excusing students to go out for lunch creates disruption to the school day and is unnecessary.

## Student Handbook Highlights

The student handbooks are a part of the student planner. Parents and students are reminded to carefully read these and acknowledge that you have done so by signing off on the release form. Some of the most pertinent points of the handbook are delineated here for further attention.

- Attendance Policy—Please note the attendance policy (page 1) explaining a student receiving half credit when he/she exceeds eight excused or two unexcused absences per semester.
- Reporting Absences—Only phone calls will be accepted. Parent or guardian may call during school hours, 7:30 a.m to 4:00 p.m. to report student absences by speaking to the attendance secretary. Please call by 9:00 a.m. on the date of absence.
- Excessive tardy to 1st Period — A student will be considered absent whenever he/she has missed the first fifteen minutes or more of first period class. A student arriving after 8:25 a.m. is considered absent, not tardy.
- Dress Code —Appropriate clothing shall be worn by the students at Elkhorn South High School. Clothing is not to be too tight, too short, too ragged, too bare, or so extreme as to be immodest. Students whose wardrobe is in question will be asked to and expected to change.
- Nuisance Items —Students are encouraged to bring only the necessary materials to school in order to maintain a productive school environment. Unnecessary items can create a distraction to the learning environment and create opportunities for theft in which the school can not be held responsible. When items such as headphones, i-pods, laser pointers, and the like become a distraction they may be confiscated by district staff and students violating this policy may be subject to district’s disciplinary rules.
- Cell phones— Cell phones should not be seen, heard, or used during the seven periods throughout the day. This applies to anywhere on campus including classrooms, hallways, restrooms, main office, media center, etc. during any scheduled instructional period (including T.A.). Students are permitted to use phones before and after school, during their scheduled lunch, and during passing periods. The following consequences may be used to address violation of the cell phone policy: parent contact, confiscation, checking in phone at start of day, detention and After Hours.
- Homework—Students are expected to complete homework in order to reinforce, practice, and enrich class content. As an ongoing effort to improve student achievement teachers and administration may use intervention strategies such as After School Academy, Guided Study Hall, Academic After Hours as necessary for homework and class work completion.
- Harassment/Bullying —Please note the policy regarding harassment, bullying, and threats. All reports of harassment will be taken seriously, investigated by the administration, and are subject to disciplinary action.

# **IMPORTANT REMINDERS ABOUT SCHOOL ATTENDANCE**

## ***Make Every Day Count!***

As the new school year draws near, the Elkhorn South High School administration would like to reiterate the Elkhorn Public Schools policy on student attendance and also provide clarity regarding statutory law and Douglas County enforcement of student attendance.

Nebraska state statute requires all school districts to adopt and administer a school attendance policy, furthermore Nebraska School Law 79-209 requires schools to report when a student exceeds 20 days per year or the hourly equivalent. Let us first address Elkhorn Public School Board Policy regarding school attendance at the secondary level.

### **Attendance and the Issuance of Credit**

School policy states that when a student exceeds **eight** total absences in any period during a semester, the student will forfeit half credit for that class. Please note that eight absences includes those that have been excused. If a student is unexcused or truant more than **twice** for any period, the student will also forfeit half credit for that class. The policy includes an appeals process for students who exceed eight absences in a given semester. It is recommended that parents collect and provide documentation of medical illness should it be necessary for an attendance appeal. The attendance appeal process includes but is not limited to a review of absence documentation and/or a meeting with school or district administration.

The school will send monthly letters to parents of students who are at pace to exceed eight absences for a given semester. These letters are intended to help parents be mindful of absences and to promote discussion with the school administration about the nature of a student's absences. The Elkhorn South administration will work diligently with families to ensure that students are attending regularly. This may include family meetings or school/community resource referrals to resolve school issues, transportation issues, or other circumstances that negatively impact student attendance.

Ultimately, the highest levels of achievement and learning are the shared goals of parents, students, and the Elkhorn Public Schools. Research clearly demonstrates the correlation between attendance and achievement, thus we

want to encourage outstanding attendance for all of our students. The high school attendance policy is not designed to punish students, but rather to emphasize the importance of regular attendance as it applies to their learning and preparation for career skills. Parents are critical in modeling responsibility as it relates to school attendance. We ask that parents keep this in mind with regards to scheduling appointments and vacations.

### **Douglas County Referrals for Excessive Absenteeism**

Should a student exceed **86 total absences**, excused or unexcused, the school will compile and submit a referral to the Douglas County Attorney. This report will include student attendance records and documentation of school interventions, parent-school communication, and medical documentation if relevant. The Douglas County Attorney's office and its community intervention team will review the information to determine appropriate levels of intervention if deemed necessary.

It is our firm belief that parents and school and community members share in their commitment to providing enriching educational opportunities to ensure student success in school. We also know the critical importance of attendance to prepare students for success in high school, but in their post-secondary endeavors as well.

Dear Elkhorn South Parents:

With opening day coming soon (Thursday, August 17<sup>th</sup>), I would like to take a few moments to address the traffic pattern at ESHS. The driveway to the student parking lot has tremendously eased our traffic concerns. However, with approximately 1300 students in the building, we will still need your cooperation to minimize traffic issues. The student parking lot driveway will be a two-way street at all times. This road should only be used by students parking and is not intended for drop-off. The main entrance is designed for student drop-off, but could also be used to access the parking lot. Please follow the information below to help traffic flow.

**The heaviest traffic flow is from 7:50-8:05am. Please make every attempt to arrive on campus before this peak time. At dismissal, the peak times in which you want to avoid the parking lot are 3:15-3:30. Thank you for your cooperation.**

During drop-off hours, the main drive to Elkhorn South will be two lanes entering and one lane exiting. This will be marked with traffic cones and signs. At dismissal time, this will switch to one lane entering and two lanes exiting.

We have three drop off loops on the property:

**Loop One-** This loop on the North side of the offices should not be used during peak drop-off and pick-up times. During peak drop-off and pick-up times, NO LEFT TURNS are permitted.

**Loop Two-** This preferred loop on the South side of the offices can be used at anytime, but please pull to the end of the loop to keep traffic flowing.

**Loop Three- This loop wraps the teachers' parking lot on the south side of the high school. After six years of studying our traffic patterns, this has proven to be the easiest route in and out of ESHS for parents. With the new classroom addition, students are closer than ever to their classrooms.**

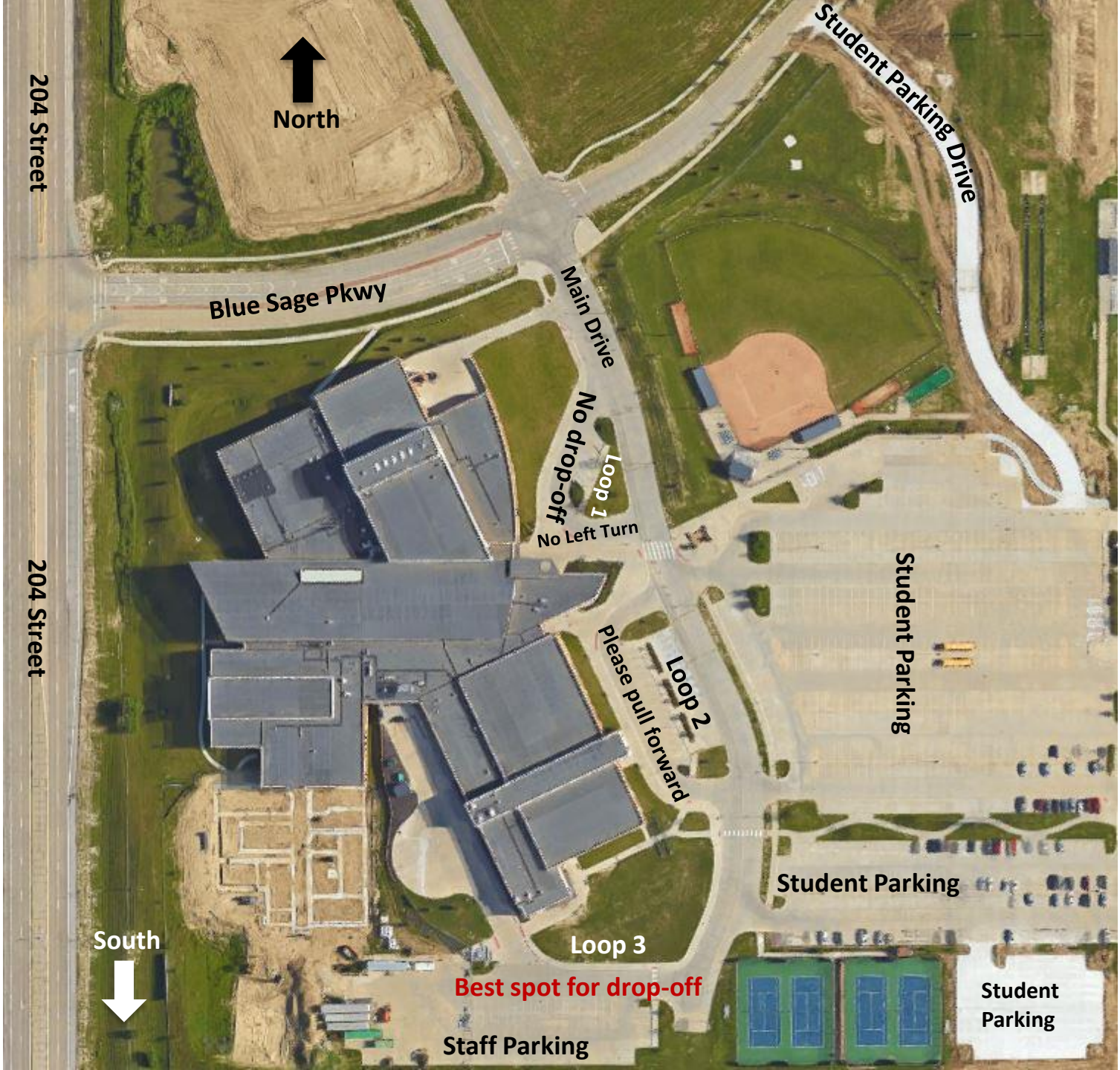
In order to keep traffic flowing smoothly, we will need your cooperation. Please remember, the building is open before 7:00am and students are welcome to study in the commons or visit lockers, etc until 7:15am, when the media center opens. After school, the media center offers tutoring until 4:30pm. All students are welcome to study, complete homework, type papers, etc in the media center until 4:30pm. Please encourage your student to utilize the After School Academy in the media center daily.

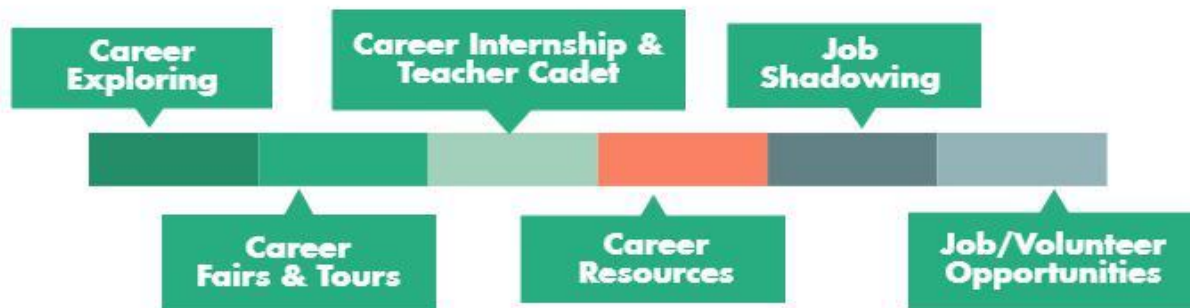

Hello and welcome to another exciting school year! We are delighted to begin another year with some new items in the cafeterias.



Regardless of grade level, your student(s) will have the opportunity for numerous meal choices daily for both breakfast and lunch. All meals meet the current USDA guidelines, and all grade levels have unlimited access to the fruit and vegetable bars with each purchased meal.

Some exciting changes for the school year include some of the following:

- Food Service will begin the process of recruiting Student Promotions Coordinators at the high school level. The ideal candidate will be a junior or senior at each high school. In their role the Student Promotions Coordinator will help design and execute marketing and promotional programs as well as assist in gaining feedback from their peers about school meals. This provides Food Service with direct student feedback and provides the student real world experience as they begin their career exploration.
- Introduce exhibition cooking in cafeterias at the secondary level to get students more involved and allow them to sample items and provide feedback.
- Further expansion and enhancement of options for deli bars to include Panini machines at the high school level
- Introduce more scratch cooking
- Carving Stations at the high school level
