To our community,

A strong partnership with our community is one of the hallmarks of the Elkhorn Public Schools. To this end, the district publishes an Annual Report to the community to provide an overview of finances, assessment results, progress updates, and more. Most importantly, the Annual Report gives us an opportunity to showcase the achievements of our students.

During the 2019-2020 school year, the District experienced its 33rd consecutive year of growth with an enrollment of 9,928 students. In 2020-2021, Elkhorn Public Schools serves over 10,700 students, an enrollment increase of 5% which maintains a five-year average increase around 7% annually and marks the 34th consecutive year of growth for the district.

Historically, Elkhorn students' test scores place them among the top statewide and nationally. We are proud of our students and know that no ranking or test score can provide a complete picture of the accomplishments that are achieved each and every day in our classrooms. As you know, the pandemic has disrupted our lives in many ways. Finishing the 2019-2020 school year with our students learning from home did not allow us to gather the data from many measurements, including assessment results normally reported annually to our community in this report.


Since the start of the pandemic, the adaptability of our educational system has been tested and all involved have been asked to teach and learn in new ways. The interdependence between school and home has been magnified like never before. Our teachers have been creative and hard working, our students resilient and engaged, and our parents exceptionally supportive and involved. 

— Student and Staff Demographics —



SCHOOL IMPROVEMENT

From March 2-4, 2020, EPS hosted eighteen distinguished leaders from across Nebraska who conducted an external accreditation review of the District. This visit was part of a system-wide accreditation process with external leaders visiting each building in the district. The process included a review of strategic documents and a variety of interviews with students, parents, community members, staff members, and administrators.

Commendations included:


- Embedded culture of high expectations
- Teacher leadership and collaborative improvement
- Data-informed instruction and continuous improvement
- Positive culture of staff commitment, student learning, and parental engagement, emphasizing an appreciation for the potential of every student.

In the spirit of a continuous improvement process, all districts receive both commendations and recommendations. EPS was pleased that recommendations strongly aligned with self-identified areas for next steps. The external team affirmed the continuation and refinement of work that has already begun for the district. Recommendation areas included continued attention to implementation of Elkhorn's Instructional Model, continued work in processes for intervention and enrichment for students, and continued refinement of purpose and protocols for collaborative teacher learning teams.



Graduate ACT

EPS graduates consistently score above both state and national averages on the ACT. For 2020 EPS graduates, the average composite score was 23.9. Results featured illustrate how 2020 EPS graduates rank in comparison to state and national averages.



Advanced Placement


EPS offers numerous, rigorous, college-level Advanced Placement (AP) courses where students may earn college credit upon successful completion of a National AP Exam.

EPS AP enrollment and the number of AP exams taken for college credit has steadily increased in the last five years. This shift is credited to the continued focus on AP course offerings and the culture of rigor at all EPS high schools.

Additionally, in 2019-2020, EPS was again honored by the College Board with placement on the AP Honor Roll for the 8th consecutive year. This recognition indicates that EPS is successfully engaging academically prepared students likely to benefit from rigorous AP coursework.

Graduation Report

The EPS Class of 2020 had a different graduation experience than previous classes as their ceremony was held outdoors for the first time in recent history due to the need for pandemic-related safety precautions. EPS was proud to be the first metro-area district to host an outdoor graduation ceremony celebrating over 600 seniors as they closed their high school careers and moved forward on the path to their futures.

District Construction Update

As part of the bond passed in 2018, funds were allocated for the construction of three new schools, including Elkhorn North High School, Elkhorn North Ridge Middle School, and Woodbrook Elementary. All three schools serve students in the northwest quadrant of the district.

In April 2018, immediately following the passing of the bond, construction began on Elkhorn North High School, with an expected opening date of August 2020. Though the pandemic caused delays, Elkhorn North, the third EPS high school, successfully opened its doors to over 600 9th-11th grade students for the first time on August 18, 2020. Woodbrook Elementary, the twelfth EPS elementary school, also welcomed students in August 2020, following the successful, on-time completion of the facility which began in May 2019. Woodbrook Elementary serves over 250 K-5th grade students. While EPS has been unable to host an in-person ribbon cutting and dedication ceremony for either facility, events will be planned as soon as feasible to allow our community to view the newest completed EPS schools.
