## ELKHORN PUBLIC SCHOOLS MINUTES OF BOARD OF EDUCATION REGULAR MEETING SEPTEMBER 14, 2015

The regular September meeting was preceded by two mandatory public hearings. Advance notice of these hearings and the Board meeting was published in the *Douglas County Post Gazette*. The agenda was available to each of the Board members prior to the meeting. The Board of Education made available a current copy of the Open Meetings Act (posted on the east wall of the Board meeting room).

Annual Budget Public Hearing – The hearing was called to order at 6:00 PM. Members present: J. Marasco, A. Parks, A. Clark, R. Riggle, S. Zingler and C. Burney. No members of the public offered comment about the proposed budget. The hearing was closed at 6:11 PM.

Annual Levy Hearing – The hearing was called to order at 6:12 PM. Members present: J. Marasco, A. Parks, A. Clark, R. Riggle, S. Zingler and C. Burney. No members of the public offered comment about the proposed budget. The hearing was closed at 6:17 PM.

The regular meeting of the Elkhorn Public Schools Board of Education was called to order at 6:30 PM. Members present: Members present: J. Marasco, A. Parks, A. Clark, R. Riggle, S. Zingler and C. Burney. Board President J. Marasco noted that the meeting was governed by the Open Meetings Act, a copy of which is posted on the east wall of the Board Room.

For the "Good News Report" J. Marasco reported that results released in August show Elkhorn students above state and national averages on the ACT Test. The District average was 24.6, the highest in Elkhorn history. Nearly 90 percent of graduating seniors took the test. Elkhorn students were again amongst the top in the state in level of mastery on the State's annual assessments. In Elkhorn 86 to 98 percent of students met or exceeded the standards across the four tested subject areas, compared to 61 to 83 percent statewide. Some notable achievements include 95 percent of Elkhorn 11th graders mastered the State's Math test, 99 percent of 5th graders mastered the Reading test and 95 percent of 8th graders mastered the Science test.

The Board received a report on ESHS Student Council Activities from Officers M. Greufe and P. Holubeck, and EHS Student Council Activities from S. Craven and R. Valquier.

Burney to approve a General Fund Budget for the 2015-2016 school year in the amount of \$79,171,330, with a Cash Reserve of \$17,725,000; a Sinking/Building Fund Budget of \$42,575,000; a Bond Fund Budget of \$15,200,150 with a cash reserve of \$7,600,000; a School Lunch Fund Budget of \$4,000,000 with a cash reserve of \$500,000; an Activities Fund Budget of \$2,225,000 with a cash reserve of \$750,000; a Depreciation Fund Budget of \$2,050,000; a Student Fee Fund Budget of \$130,000 with a cash reserve of \$50,000 and an Employee Benefit fund of \$750,000.
