ELKHORN PUBLIC SCHOOLS MINUTES OF BOARD OF EDUCATION PUBLIC LAND HEARING & REGULAR MEETING JULY 11, 2016

The regular meeting of the Elkhorn Public Schools Board of Education was called to order at 6:30 pm. Members present: J. Marasco, A. Parks, A. Clark, R. Riggle, S. Zingler and C. Burney. J. Marasco noted that the meeting was governed by the Open Meetings Act, a copy of which is posted on the east wall of the Board Room.

For the "Good News Report" J. Marasco acknowledged that projects across the District are taking shape as part of the bond issue passed by voters in November 2014. Several projects will be ready for the start of the 2016-2017 school year, including Elkhorn's 10th Elementary School—Arbor View Elementary; the gymnasium addition and safety remodel at Elkhorn Middle School; a classroom addition at Elkhorn South; and classroom remodel projects at Elkhorn High School. The District warehouse opened earlier this month and crews continue to work to transform the 1950's cafetorium building into a new teacher training and conference center. In August, EPS will welcome a yet another record hiring class of 82 new teachers.
