Notice of this meeting was published three times in the Douglas County Post Gazette, a legal newspaper published in and of general circulation in Douglas County, Nebraska, and designated as the official newspaper of the Elkhorn Public School District for the publication of notices. Notices were published on November 22, 2016, November 29, 2012, December 6, 2016, the last publication being at least ten days prior to today's date. A Notice of this public hearing was also provided to the owner and all known persons having an interest by United States mail. A copy of the Notice published in the Douglas County Post Gazette will be attached to the minutes of this public hearing, as well as a copy of the Notice of Acquisition provided to the owner of the private identified in the Notice. This Public Hearing relates to the proposed acquisition of property private property for public purposes. The specific property, identified by street address or legal

description is as follows:

Briefly described as the irregular north 43 acres in the West ½ of the Southwest ¼ of Section 4, Township 15, Range 11 in Douglas County, Nebraska. A detailed and legal description will be provided at a later date upon completion of a land survey of the property to be acquired.

### IV. Land Acquisition Public Hearing -

Superintendent of Elkhorn Public Schools, Stephen Baker will address the Board and explain and discuss the nature of the proposed school project, the necessity for a high school project, the reason or reasons for selecting the particular location for the high school site, and the quantity of property necessary to fulfill the public purpose of a high school site.

Attorney for the School District, Duncan Young, will address the Board and the Public in attendance to explain 1) the power of the school district to exercise eminent domain under Nebraska statutes; 2) the right of the owner to have representation in negotiations with respect to the property; 3) the obligation to negotiate in good faith; 4) the right of the property owner to representation by counsel; 5) the right to require compensation for the taking of such property be determined pursuant to the procedures for acquisition by eminent domain; 6) that the District will pay fair market value; and 7) that the District will purchase fee simple together with permanent or temporary easements.

It is at this point in the time of the Public Hearing when members of the public are invited to address the Board on any matters relating to the proposed action. We would ask that when addressing the Board, you attempt to keep your comments to five minutes, more or less if you are an owner of property, and three minutes, more or less, if you are not an owner of the specific piece of property. I will first ask the property owners or their representatives and, secondly, from all others wishing to address the Board in this public hearing.
