## ELKHORN PUBLIC SCHOOLS MINUTES OF BOARD OF EDUCATION REGULAR MEETING November 13, 2017

The regular meeting of the Elkhorn Public Schools Board of Education was called to order at 6:30 pm. Members present: J. Marasco, C. Burney, A. Clark, A. Parks, R. Vokt, and S. Zingler. Board President J. Marasco noted that the meeting was governed by the Open Meetings Act, a copy of which is posted on the east wall of the Board Room.

For the "Good News Report" J. Marasco acknowledged West Dodge Station elementary was named to Scholastic's "Best in State" list for their participation in the Scholastic Summer Reading Challenge. WDS students read 528,000 minutes over the summer, putting the school in the top 40% of "Best in State" schools. 12 Elkhorn South students and 27 Elkhorn High students were named to the 2017-2018 Vocal Music All-State Musicians list and 16 ESHS students and 12 EHS will represent Elkhorn Public Schools at the Nebraska Music Educators Association's All - State Conference as part of the Band, Chorus, Jazz Band and Orchestra All-State Musicians list.
