

**ELKHORN PUBLIC SCHOOLS  
MINUTES OF BOARD OF EDUCATION  
REGULAR MEETING  
July 15, 2019**

The regular meeting of the Elkhorn Public Schools Board of Education was called to order at 6:30 PM. Members present: J. Marasco, A. Clark, A. Parks, R. Vokt, and N. Rogic-Greufe. C. Burney absent and excused. President John Marasco noted that the meeting was governed by the Open Meetings Act, a copy of which is posted on the east wall of the Board Room.

For the "Good News Report" J. Marasco recognized NSAA Cup Class B All-School Standings were recently released with Elkhorn High athletics earning 2<sup>nd</sup> overall, and Elkhorn South athletics earning 3<sup>rd</sup> overall. Special congratulations to Elkhorn High girls' athletics on earning 1<sup>st</sup> place in the Class B Girls standings! A special presentation ceremony will be held in the fall to celebrate this achievement! Additionally, Over 200 EPS middle school band students participated in the Summer Band program, which concluded with a concert where they commissioned and gave the world premier of "Excelsior", composed by Robert Langenfeld.
