

**ELKHORN PUBLIC SCHOOLS
MINUTES OF BOARD OF EDUCATION
REGULAR MEETING
JULY 6, 2020**

The regular meeting of the Elkhorn Public Schools Board of Education was called to order at 6:30 PM. Members present: J. Marasco, C. Burney, A. Clark, A. Parks, R. Vokt, and N. Rogic-Greufe. President John Marasco noted that the meeting was governed by the Open Meetings Act, a copy of which is posted on the east wall of the Board Room.

For the "Good News Report" J. Marasco stated that six EPS Class of 2020 graduates were recently recognized by Governor Ricketts and the Nebraska Department of Education for receiving a perfect 36 on their ACT. Notably, Elkhorn South, with 4 graduates recognized, had the most students honored from an individual school in the state.
