MINUTES OF BOARD OF EDUCATION
REGULAR MEETING
OCTOBER 11, 2021**

The regular meeting of the Elkhorn Public Schools Board of Education was called to order at 6:30 PM. Members present: C. Burney, A. Parks, S. Ringenberg, N. Rogic-Greufe, J. Shatel, and R. Vokt. President A. Parks noted that the meeting was governed by the Open Meetings Act, a copy of which is posted on the north wall of the Teacher Training Conference Center. Advanced notice of the Board meeting was published in the Douglas County Post-Gazette on September 22, 2021.

The meeting began with Student Council reports from each high school and citizen comment. Public comment was heard. For the "Good News Report" A.
