Annual Budget Public Hearing – The hearing was called to order at 6:00 pm. Members present: C. Burney, A. Parks, S. Ringenberg, N. Rogic-Greufe, J. Shatel, and R. Vokt. Chief Financial Officer H. Shepard gave a presentation on the proposed 2022-23 budgets. The presentation budget summary and full District budget were made available to the public. Time was allowed for public comment on the proposed 2022-23 Budget including the General Fund, Bond Fund, Activity Fund, Student Fee Fund, School Nutrition Fund, Depreciation Fund, Special Building Fund and Employee Benefit Fund. The hearing was closed at 6:13 PM.

Annual Levy Hearing – The hearing was called to order at 6:14 PM. Members present: C. Burney, A. Parks, S. Ringenberg, N. Rogic-Greufe, J. Shatel, and R. Vokt. Chief Financial Officer H. Shepard was available for questions on the proposed 2022-23 property tax requests. Time was allowed for public comment on the proposed 2022-23 System-wide Property Tax Request for the General Fund, Special Building Fund, and Bond Fund. The hearing was closed at 6:17 PM.

The regular meeting of the Elkhorn Public Schools Board of Education was called to order at 6:30 PM. Members present: C. Burney, A. Parks, S. Ringenberg, N. Rogic-Greufe J. Shatel, and R. Vokt. President A. Parks noted that the meeting was governed by the Open Meetings Act, a copy of which is posted on the east wall in the Board Room of the District Office. Advance notice of the Board meeting was published in the Douglas County Post-Gazette on September 7, 2022.

The meeting began with public comment and reports from Student Council representatives from all three high schools in the district. During the "Good News Report," S.
