#### Dress Code Reminder

The Middle School dress code has been one of common sense, parental approval, and personal pride. Like behavior, an individual's dress should reflect sensitivity and respect for themselves and others. The following directions governing dress and personal grooming seek to encourage the student to take pride in his/her appearance, and to aid the student in developing the habit of good taste in personal appearance.

The following clothing or types of dress are **PROHIBITED**:

- 1. Dress which causes or has the potential to cause either a substantial disruption or material interference with the educational process.
- 2. Clothing which is too short, too tight, too revealing, or is inappropriate for school.
- 3. Dress which contains vulgar or offensive words or symbols or is sexually explicit, indecent, or lewd. Dress which reflects lack of sensitivity or respect for others is unacceptable.
- Dress which promotes, advocates, or ad vances the use of alcohol, tobacco, or illegal drugs, including clothing which displays the logo or trademark of any brand(s) of alcohol, tobacco, or illegal drugs.
- 5. Sagging pants are not appropriate for school. Pants should be worn so that undergarments are not higher than the pants. The length of shirt worn to cover up the undergarments is not relevant.
- Any gang-related symbol worn, written, carried, displayed, or communicated will not be tolerated (i.e., hats, caps, coats, sagging pants, bandannas, pagers, and/or handkerchiefs). Hats and sunglasses may be worn to school, but will not be worn in the halls or in any classes.
- 7. Any items which would detract from the educational environment will not be acceptable.

Dress code violations will be addressed with students by counselors or Administrators. Parents will be notified of a dress code infraction and be asked to supply the appropriate clothing for the student immediately. If parents/ guardians cannot supply appropriate clothing, the student will be given clothing to wear that day from a friend or possibly from the lost and found. Continuous violations will result in disciplinary action




In Science, 7th graders are working through the Motion and Forces unit. We have discussed what motion is and different ways we can describe the motion of an object. After Spring Break, we will be moving on to the Forces portion of the unit. In this part, we will discuss forces such as friction and gravity and the effect they have on the motion of an object. We will also discuss and look for everyday examples of Newton's Laws of Motion.

In Math, students have been participating in "Boot Camp" to help prepare them for MAP and NSCAS testing. During testing, students will be working on lessons primarily during class, so students will not have much homework. Once testing has been completed, we will return to normal lessons and homework.

In World History we are finishing up learning about Africa and Asia. We will be turning our attention next to World War I.

April is National Poetry Month, so Reading and Language Arts classes will be focusing on poetry for most of the month. In Reading class, we will be analyzing published poems from our textbook as well as outside sources, and discussing/finding poetic terms within the poems. Language Arts will do some poetry writing to coincide with our unit, and then students will complete a poetry project that combines lessons from both classes. Language Arts will then end the month with a Mechanics Common Assessment.

#### "Turning Tragedy into Testimony"

As a senior at Millard South high school, Kyler Erickson witnessed a school shooting, done so by one of his classmates. As it turned his world upside down, he struggled to find hope in such a horrific time. It took him a year and a half to finally admit to, and seek help for his Post-Traumatic Stress Disorder.

He first talked to his family and close friends, telling them how much mental pain he was going through. Kyler went through months and months of vigorous therapy.

After being healed and finding peace, he followed his dreams and is currently speaking in Omaha and hundreds of places all around the country. Kyler has not, and will not stop showing people how much they are loved. He focuses on mental illness and overcoming obstacles. Kyler is a kid with an incredible story, and an even bigger heart. He refuses to be stopped, on his way to changing lives.

#### SPORTS PHYSICALS FOR 2019-2020

All 7th & 8th graders for the 2019-2020 school year who plan to participate in sports at EGMS will need a sports physical. Please contact your health care provider to arrange for your child to get a Sports Physical for next year. Keep in mind that Sports Physicals for next school year must be dated after May 1, 2019.
