Dear Elkhorn Community,

Each year, the Elkhorn Public School District publishes an Annual Report to the community to provide an overview of District finances, updates, and test scores. More importantly, the Annual Report gives us an opportunity to showcase the achievements of our students.

The more than 6,000 students who make up the Elkhorn Public Schools continue to thrive in the classroom and in their community. Elkhorn students' test scores place them among the top in the state and more than 89 percent of our students go on to attend a two or four-year college after graduation.

In November 2012, the Nebraska Department of Education (NDE) released a list of rankings for school districts across Nebraska, the Nebraska Performance Accountability System (NePAS). Elkhorn was ranked Number One in writing out of the state's 249 school districts and was the only school district in the state to place among the top 10 in all four subject areas. {OUR MISSION}

Elkhorn Public Schools unites students, families, educators, and the community to ensure a challenging and enriching academic environment that inspires students to develop the knowledge and skills necessary to become responsible citizens and lifelong learners.

{OUR DISTRICT}

Elkhorn Public Schools (EPS) is a rapidly growing suburban school district located on the west edge of the Omaha Metro area. Our enrollment continues to climb by more than six percent each year, and we continue to add facilities to accommodate our growing student population. The District offers the cultural, educational and retail advantage of the city, while still maintaining the qualities of a smaller community. We pride ourselves on the achievement of our students and the dedication of our staff.

EPS currently maintains 12 school buildings as well as an Early Education Center. In November 2011, Elkhorn voters approved a \$49.1 million bond issue to build two new elementary schools (opening 2013) and a new middle school (opening 2014).

Our students consistently score well above state and national averages on standardized assessments. EPS maintains a culture of continuous improvement and continues to raise the bar for all students.

This Annual Report offers important and detailed information about the curriculum, demographics and assessment data from the Elkhorn Public School District during the 2011-12 school year.

{OUR COMMUNITY}

Students and families in Elkhorn benefit from a strong sense of community support in and out of their neighborhood schools.

Our schools see high levels of parental involvement, with more than 98 percent of elementary parents attending semester Parent/Teacher conferences. Local business and individuals are also key to the success of our schools with support for the Elkhorn Public Schools Foundation and District programs such as Partners in Education Mentoring.

The Elkhorn community has passed eight major bond issues since 1992 and has supported the opening of seven new schools, with three more under construction, since 2000. Support from our community has been essential to accommodating the rapidly growing student population while maintaining our high standards for student achievement.

WE ARE ELKHORN {EXPECTATIONS}

(GRADUATION REQUIREMENTS)

In order to graduate from an Elkhorn high school, a student must accumulate 42 credits (210 semester hours) that must include the following:

- 8 Credits of English
- 6 Credits of Social Science

(must include American History and American Government)

- 6 Credits of Mathematics (Must include Algebra 1)
- 6* Credits of Science (Must include Biology)
- 2 Credits of Physical Education
- 1 Credit of Technology
 - (Career Information Technology Course)
- 14 Credits of Electives

Students planning to attend a four-year college or university after graduation are encouraged to take the recommended ACT CORE CURRICULUM, which includes four years of English; three or more years of Math (with Algebra I, II and geometry as the minimum); three or more years of social science; and at least three years of natural science. *Beginning with the graduating class of 2015, students must complete six hours of science credits.

{HIGH SCHOOL COURSE OFFERINGS}

Elkhorn High Schools offer a total of 689 instructional units (state minimum is 400) in the subject ares of Language Arts, Social Sciences, Mathematics, Science, Foreign Language, Career/Technical Education, Physical Education/Health and Visual Performing Arts.

{ADVANCED PLACEMENT COURSES}

Elkhorn High Schools offer rigorous, college-level Advanced Placement courses in English Literature and Composition, English Language and Composition, Calculus (AB and BC), Chemistry, Biology, U.S. History, and European History. Students may earn college credit in any of these classes upon successful completion of a National Advanced Placement Exam in May.


{NeSA ASSESSMENTS}

Each spring, students in grades three though eight as well as eleventh grade take the Nebraska State Accountability assessments (NeSA) in writing, reading, math and most recently added in 2012, science. Elkhorn students showed high levels of mastery across grade levels and subject areas, scoring well above state averages.

On all NeSA assessments, students fall into one of three categories: Below Standards, Meets Standards or Exceeds Standards. The State is responsible for setting the *cut scores*, which determine how a student must score in order to fall in each of the three categories.

NeSA-WRITING


Since its induction in 2006, Elkhorn students have shown very high levels of mastery on the NeSA-W, with more than 98 percent of students mastering state standards. In 2012, the state revised the NeSA-W to a more rigorous online assessment for grades 8 and 11.




NeSA-MATH

2011-12 marked the second year of the NeSA Math assessment. Elkhorn students maintained high levels of mastery especially at the higher grade levels.

Elkhorn's two high school were again among the top in the state for levels of mastery on the NeSA-M assessment. Eighty-five percent of Elkhorn eleventh graders mastered the test compared to an average of 56 percent statewide.









NeSA-READING

2011-12 marked the third year of the State Reading Assessment, NeSA-R. Elkhorn students again showed high levels of mastery with 85 to 96 percent of students meeting or exceeding the standards. Elementary students made gains at all tested grade levels, with gains ranging from 3 to 7 percent.



NeSA-SCIENCE

In 2012, the State launched the NeSA Science test for students in grades 5, 8 and 11. Elkhorn students were among the top in the metro area in level of mastery. Notably, 92 percent of Elkhorn 8th graders mastered the assessment compared to the state average of 67 percent.



WE ARE ELKHORN {NATIONAL TESTS}

{STANFORD TEN}

Elkhorn Students in grades three through nine took the Stanford Ten (SAT 10) Achievement test in April. The comprehensive standardized achievement test allows parents and teachers to measure student progress against a nationally representative sample of students at the same grade level.

Stanford Ten information is shared with parents and also used by teachers to identify curriculum strengths and weaknesses. Results in the following graphs indicate the percent of students in the national norm group who scored lower than Elkhorn students. For example, a percentile rank of 84 indicates that Elkhorn students, as a group, scored higher than 84 percent of their peers in the national sample. Elkhorn students consistently score well above the 50th percentile national average.


AS A GROUP, ELKHORN STUDENTS OUTSCORED

SAT 10 MATH




SAT 10 READING

{PLAN TEST}

The PLAN test is given annually to all Elkhorn tenth grade students. This test is developed by the American College Testing Service (ACT) and is used to gather a variety of information, including: educational plans, career interests, predicted ACT scores and academic need areas. Elkhorn students as a group have consistently performed above national averages on this assessment.




NATIONAL AVERAGE ELKHORN AVERAGE



$\{ACT\}$

The ACT measures the skills and higher order thinking necessary to be successful in college. In 2012, the overall average composite score for Elkhorn seniors was 23.7 and the average math score for Elkhorn seniors reached 24, the highest in District history.

As a group, Elkhorn students consistently score above both the State and National averages. Also notable, is that more than **85 percent** of 2012 Elkhorn graduates took the ACT Test.

{HIGH SCHOOL ACTIVITIES}


practices. AdvancED allows the District to participate in an external and objective review of the District.







{NePAS}

The Nebraska Performance Accountability System (NePAS) is a ranking system of all school districts in the state set forth by the Nebraska department of education. Rankings reflect the total number of school districts in the state (249). It is important to note: as a district improves its status ranking, it will be more difficult to achieve high rankings in the area of growth as students near the achievement "ceiling." For example: a student who scores a perfect score one year will only be capable of a zero in growth the following year.

STATUS rank is based on the average NeSA scale scores and represent the overall achievement level of the district.

ELKHORN STATUS RANKINGS:

READING- #3 MATH- #8 SCIENCE- #10 WRITING- #1

IMPROVEMENT rank is based on the same grade-level from year to year and measures different groups of students. Improvement was only measured in the areas of reading and math for 2011-12.

ELKHORN IMPROVEMENT RANKINGS:

READING- #87 MATH- #88

GROWTH rank is based on the same group of students as they progress through the grade levels. Growth was only measured in the areas of reading and math for 2011-12.

ELKHORN GROWTH RANKINGS:

READING- #56 MATH- #56

GRADUATION RATE rank is based on the "graduation cohort." The graduation cohort is assigned when a student enrolls as a ninth grader. Students must fulfill the high school graduation requirements within four years to graduate with their cohort.
