ELKHORN PUBLIC SCHOOLS MINUTES OF BOARD OF EDUCATION REGULAR MEETING SEPTEMBER 14, 2020

The regular monthly meeting was preceded by two mandatory public hearings. Advance notice of these hearings and the Board meeting was published in the Douglas County Post-Gazette on August 26, 2020. The Board of Education made available a current copy of the Open Meetings Act, a copy of which is posted on the east wall of the Board Room.

Annual Budget Public Hearing – The hearing was called to order at 6:00 pm. Members present: J. Marasco, C. Burney, A. Parks, R. Vokt, A. Clark, and N. Rogic-Greufe. Chief Financial Officer P. Roth gave a presentation on the proposed 2020-21 budgets. At least three copies of the presentation budget summary and full District budget were made available to the public. Time was allowed for public comment on the proposed 2020-21 Budget including the General Fund, Bond Fund, Activity Fund, Student Fee Fund, School Nutrition Fund, Depreciation Fund, Special Building Fund and Employee Benefit Fund. No members of the public offered comment about the proposed budget. The hearing was closed at 6:13 PM.

Annual Levy Hearing – The hearing was called to order at 6:14 PM. Members present J. Marasco, C. Burney, A. Parks, R. Vokt, A. Clark, and N. Rogic-Greufe. Chief Financial Officer P. Roth was available for questions on the proposed 2020-21 property tax requests. Time was allowed for public comment on the proposed 2020-21 Systemwide Property Tax Request for the General Fund, Special Building Fund, and Bond Fund. No members of the public offered comment about the proposed levy. The hearing was closed at 6:16 PM.

The regular meeting of the Elkhorn Public Schools Board of Education was called to order at 6:30 PM. Members present: J. Marasco, A. Parks, A. Clark, C. Burney, R. Vokt, and N. Rogic-Greufe. President John Marasco noted that the meeting was governed by the Open Meetings Act, a copy of which is posted on the east wall of the Board Room.

It was moved by C. Burney and seconded by A. Parks to approve the Consent Agenda items including: approval of agenda, approval of minutes for Monday, August 10, 2020, approval of September bills for payment as presented.

Clark to approve to approve a General Fund Budget for the 2020-2021 school year in the amount of \$117,768,918, with a Cash Reserve of \$22,825,000; a Special Building Fund Budget of \$58,675,000; a Bond Fund Budget of \$88,114,997 with a cash reserve of \$14,180,000; a School Nutrition Fund Budget of \$6,500,000 with a cash reserve of \$500,000; an Activities Fund Budget of \$2,500,000 with a cash reserve of \$750,000; a Depreciation Fund Budget of \$4,500,000; a Student Fee Fund Budget of \$250,000 with a cash reserve of \$125,000 and an Employee Benefit fund of \$950,000.

terms of the bonds; providing for the levy and collection of taxes to pay the principal of and interest on the bonds; and related matters.
