If you are planning to speak about a personnel or student matter involving an individual, please understand that board policies require that such concerns initially be directed to the administration for consideration. Board members will generally not respond to any questions you ask or comments you may make about individual staff members or students. You are cautioned that slanderous comments are not protected just because they are made at a board meeting. Please remember this is a public meeting for the conduct of the business of the Board of Education. Offensive language, personal attacks and hostile conduct will not be tolerated. The Board President may order persons who are disorderly to be removed from the meeting. Recording of the meeting is allowed, except for executive (closed) sessions, provided that the Board President is notified and that the recording device does not interfere with the meeting.  - A. During a closed session no action will be taken by the Board, and all discussion will be limited to the announced reason(s) for entering the closed session. Following the closed session, the Board will reconvene before adjournment.

 - A. Notice of Settlement of Claim** - Per Neb. Stat. 84-713, a settlement has been reached in a claim against the District by Barbara Hickson. The claim involved an accident on June 2, 2018. The District's insurance carrier settled the claim in the amount of \$350,000.00 in exchange for a release of liability. The entire settlement amount will be paid by the District's insurance carrier and not from any taxpayer funds.
