ELKHORN PUBLIC SCHOOLS MINUTES OF BOARD OF EDUCATION REGULAR MEETING MARCH 11, 2024

The Regular Monthly Meeting of the Elkhorn Public Schools Board of Education was called to order at 6:30 PM. Members present: A. Parks, N. Rogic-Greufe, S. Ringenberg, J. Shatel, R. Vokt, and M. Wortman. President A. Parks noted that the meeting was governed by the Open Meetings Act, a copy of which is posted in the Board Room of the District Office. Advance notice of the Board meeting was published in the Omaha World Herald on March 4, 2024.

The meeting began with Student Council reports from each high school followed by public comment. During the "Good News Report," Jennifer Shatel recognized that on February 20th, the superintendent and high school principals welcomed, The Adjutant General for Nebraska, Major General Craig Strong and Command Sgt. Maj. Krecklow to the District for a meeting to discuss partnerships and opportunities. The state mission of the Nebraska National Guard is to provide trained and equipped organizations to protect life and property and to preserve peace, order and public safety. Nebraska National Guard troops are called to state active duty to execute missions within the State when authorized by the Governor. The Adjutant General of Nebraska reports directly to Governor Pillen and serves as both the Senior Military Officer in Charge of the Nebraska National Guard as well as the State Emergency Management Director. The Adjutant General for Nebraska, Command Sgt. Maj. Craig Strong gave each District leader one of his personal Challenge Coins to commemorate the visit and our ongoing partnership. Notably, on Wednesday, February 28th, the school board made its fourth tour of the year visiting West Bay, Spring Ridge, West Dodge Station, and Manchester elementaries, Elkhorn Ridge Middle School and the Young Adult Program. The Board witnessed students engaging in activities that will promote lifelong learning skills. A big thank you to all teachers, support staff and administrators - a job well done! Additionally, EPS students Reese Chard, Georgia Chyczy, Yuridia Hernandez-Tapia, and John Karnett have been recognized for scoring in the top 10% of Nebraska students on the PSAT/NMSQT. Congratulations to all on this academic achievement! Lastly, various EPS art students have recently been recognized for their work, including: Roman Madlinger, ESHS 11th grader, awarded the UNL Nebraska Young Artist Award and the Omaha Summer Arts Festival Young Artist Exhibition illustrator; 45 ESHS artists received awards in the Nebraska Scholastic Artshow, including 6 student portfolios; 11 EVVMS artists received awards in the Nebraska Scholastic Artshow
